# **DRIVING DIRECTIONS TO UNION SOUTH:**

To Lot 80 (Union South garage):

# From the Madison Airport:

Exit the rental car lot onto International Lane.

Turn left onto Packers Avenue when International Lane ends.

Packers Avenue becomes Pennsylvania Avenue then E. Johnson St. then E. Gorham St. then finally University Avenue.

Approximately 4+ miles after leaving the airport, turn left on N. Randall Avenue; 5. Cross over Campus Drive then turn left on W. Dayton St.

6. The ramp for the Union South garage will be on your left.

## From I-90 (North or South):

Exit at US-12 W/US-18 W/W Beltline Hwy.

Take the US-151 N/Park Street exit, EXIT 261.

Turn right onto Park Street.

After approximately 3 miles, turn left onto W. Dayton Street.

After traveling through one traffic light, Union South will be ahead on your right, near the end of W. Dayton Street, just before the intersection of W. Dayton Street and N. Randall Avenue.

# From Baymont Madison West:

Head South toward Excelsior Dr

Turn left onto Excelsior Drive; Continue on Old Sauk Rd Merge onto University Ave/ Campus Dr to W Dayton St Turn left onto W Dayton St; Destination will be on the left.
