## DRIVING INFORMATION

For GPS users, the Student Union address is 1303 E University Blvd. Tucson, AZ 85719

Directions from the Phoenix area to the University of Arizona:

Take I-10 East to Tucson. Exit I-10 at Speedway Boulevard/University of AZ (exit #257). Turn EAST/LEFT onto Speedway. Continue EAST on Speedway to Mountain Avenue Turn SOUTH/RIGHT onto Mountain Avenue Turn EAST/LEFT onto E. 2nd Street. Enter Second Street Garage on your right.

From Tucson International Airport to UA:

Exit on South Tucson Boulevard. Turn onto Kino Parkway. Kino Parkway turns into Campbell Avenue. Take Campbell Avenue north to Speedway Boulevard. Turn LEFT/WEST onto Speedway Boulevard. Turn LEFT/SOUTH on Mountain Avenue. Turn EAST/LEFT onto E. 2nd Street. Enter Second Street Garage on your right. [Interactive Campus Map](#).

Do not park in specially assigned spaces such as Reserved or Handicap (unless a state-issued disabled placard accompanies the vehicle).
