LOCATION

The UTSA Law Fair will be held at <u>UTSA Main (1604) Campus</u> in <u>Student Union (SU)</u> 2.01.28 Denman and 2.01 Denman Galleria. The SU Building is located across the H-E-B Student Union. Lunch will be held at H-E-B Student Union 2.212 – Harris, located across the Student Union Building. The break room will be SU 2.01.26, Pecan, next to the Denman Room. Please visit the <u>UTSA interactive map</u> to locate each room.

CAMPUS PARKING/RIDE SHARE DROP OFF INSTRUCTIONS

If driving, plan to arrive early to allow time for parking. You may park at the Ximenes Garage, (XAG) located between the H-E-B UTSA Student Union and Applied Engineering and Technology buildings. The XAG is the closest to the UTSA Student Union. Hourly parking is \$2.50 per hour. The Ximenes Garage pay stations are located at the stairwell and outside the cashier station. Payment is required before returning to the vehicle. If taking a ride sharing option, request drop off at the entrance of the Ximenes Garage. The Student Union building is across the H-E-B Student Union. An accessible route is available once you exit the Ximenes Garage, just take a right across the crosswalk and you will see the H-E-B Student Union building. Continue on the sidewalk, and you will find the ramp located on the right side of the building. Continue on the ramp will take you directly the H-E-B Building. Use the elevator to the second floor and cross the bridge that connects with the Student Union building. The Denman Room and Galleria are right there. Please visit the UTSA interactive map.
